

General Terms and Conditions

These terms and conditions are valid for all Westerdijk Institute course events. When you register for one of our courses you agree to be bound by the terms and conditions mentioned below. All registrants must read and complete the terms and conditions.

Registration

Registration is required two weeks in advance of the start date of the course and will be considered on a first come, first served basis. However, there are occasions when we can accept late registrations. If you would like to register for a course after the deadline, please contact us directly for availability. Registrations should be submitted via our website. Your registration is complete upon receipt of confirmation from us. You will receive a confirmation of your registration via e-mail.

Fee

It is Westerdijk Institute policy that all course fees be paid for in advance of the course event, by cash, bank transfer or credit card (MasterCard or Visa only). Details of payment methods will be included in your registration confirmation. We will give you access to the course when full payment has been made; however, if you choose to pay by bank transfer, your access will not be granted until your transfer has cleared. The fee shall cover the course registration and participation, and all other course content.

Cancellation

Cancellations without penalty must be sent at least one month prior to the commencement of the course. Cancellation after this date incurs the following penalties:

- Between 1 month and 2 weeks before course commencement 50% refund
- Less than 2 weeks no refund

Cancellations may be submitted by letter or e-mail and are considered accepted upon confirmation from us.
